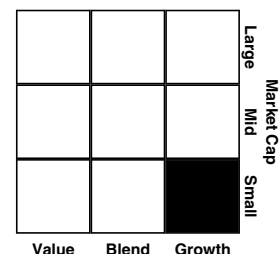


Invesco Discovery Fund (Y)

The Fund managers consider a small-capitalization company to be one that has a market capitalization within the range of market capitalizations of the Russell 2000 Growth Index.
