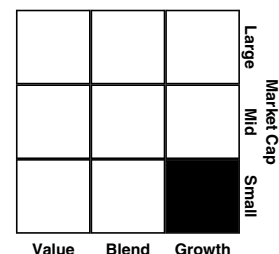


The Fund seeks capital appreciation. The Fund mainly invests in common stocks of U.S. companies that have favorable growth prospects. It emphasizes stocks of small-capitalization companies. The Fund managers consider a small-capitalization company to be one that has a market capitalization within the range of market capitalizations of the Russell 2000 Growth Index.
